- **Import VAT 7% on sold item amount to Thai Custom**
- **For early delivery before the show 1 day at the show site, there will be an additional charge at USD 100.**
- **All the above rates are subject to 7% VAT.**

### **Note**

- **All charges are per consignment.**

### **Rate inclusive of :**

- Handling service from Bangkok Airport to the show and from the show to Bangkok Airport.
- Import and export customs clearance under bonded facilities in Bangkok.
